## IN ORDER TO RECEIVE "STALLION AWARDS" ON CERTIFIED ARIZONA-BREDS OF ANY GIVEN YEAR

1. A nomination fee for each stallion is required. A nomination fee of \$150 is due by March 1st of the current breeding year or a nomination fee of \$250 is due from March 2nd through August 1st of the current breeding year nomination fees will NOT be accepted after August 1st. Nomination fees are Non-Refundable.
2. A Renewal Fee for each stallion is required for each year after the nomination fee is paid. A renewal fee of \$100 is due by March 1st of the current breeding year or a renewal fee of \$200 is due from March 2nd of the current breeding year. Renewal fees will NOT be accepted after August 1st. Renewal fees are Non-Refundable.
3. If a stallion owner, Lessee or Agent fails to meet any of the requirements set forth by the AQRA the failure shall result in a stallion being ineligible for stallion awards for the affected fiscal year.
4. To reinstate a disqualified stallion for the next fiscal year, the owner, Lessee or Agent shall meet all the original requirements for the original nomination.
5. Only Certified Arizona-bred horses are eligible to earn stallion awards for their eligible sires.
6. Thoroughbred stallions bred to quarterhorse mares, the Owner, Lessee or Agent shall send the application, fees and breeding reports to BOTH, the AQRA and the ATBA.

or late fee through August 1st - \$200
